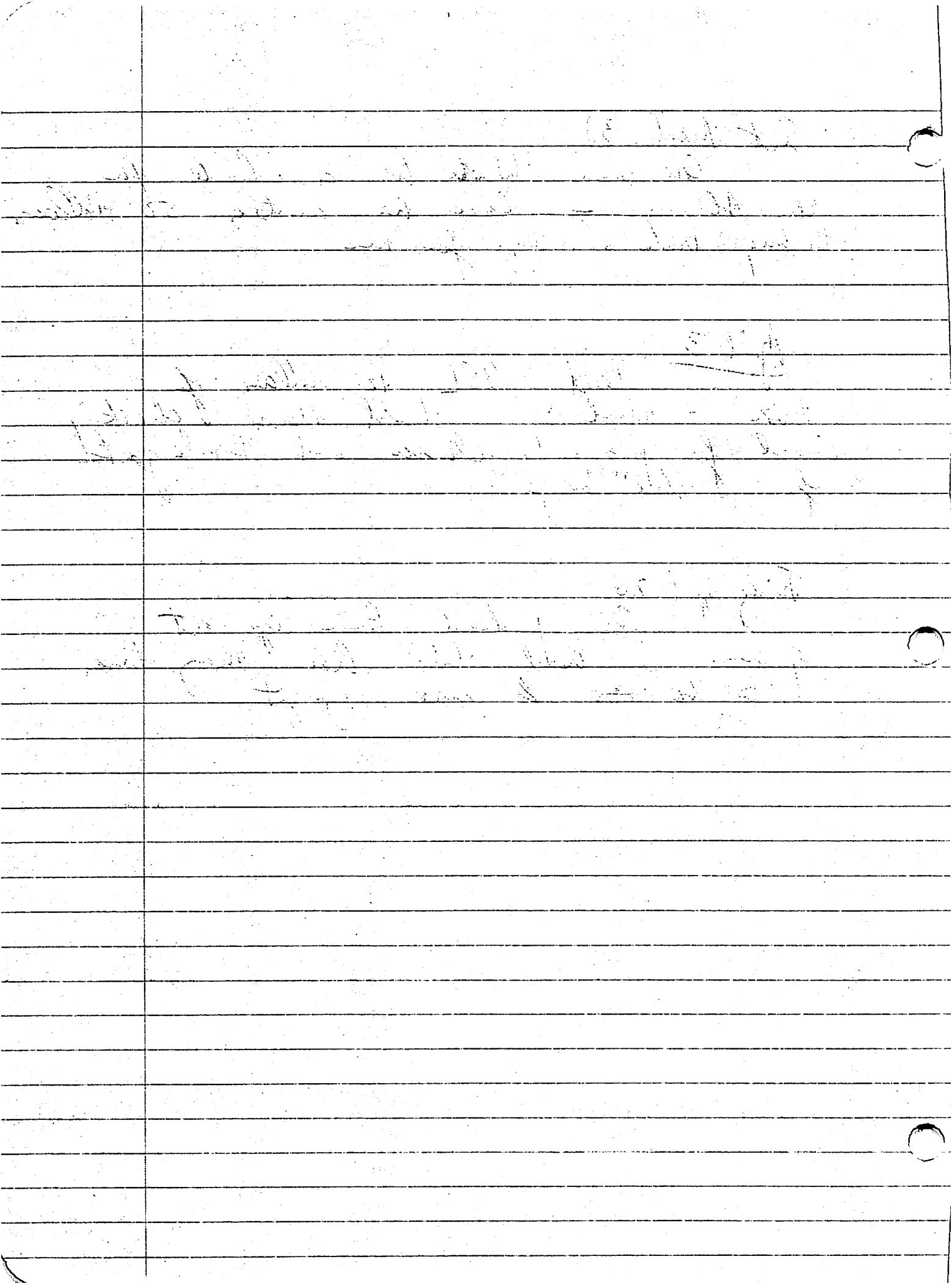
Qw came. Write her a check for the Alimony. - gave her another 50 dollars to buy Brian's toys for me.

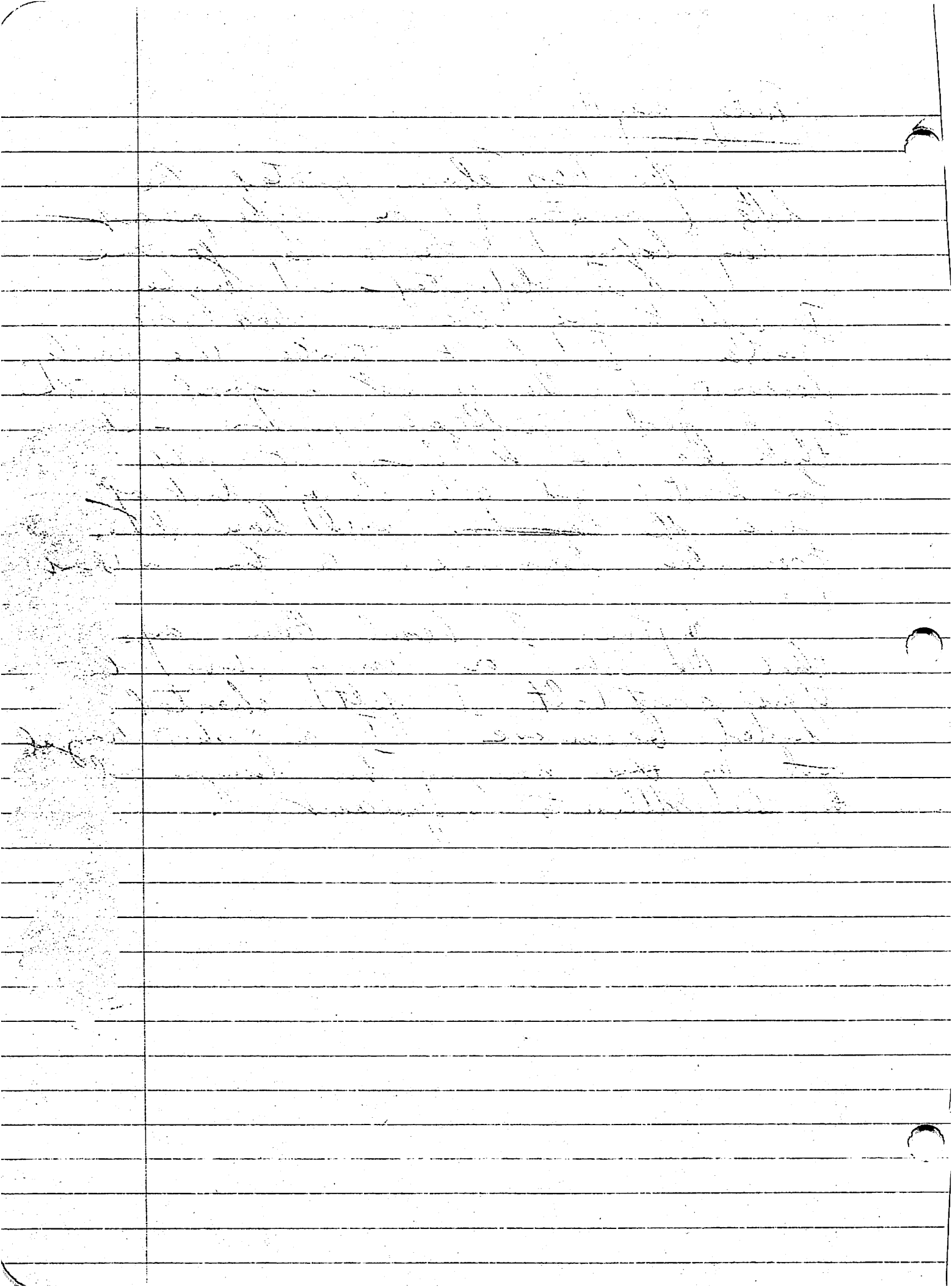
